



SEIAA gone through the letter of Ramdev Saroj, Mirzapur dated 16/10/2019 regarding illegal mining. SEIAA opined that the above letter must be referred to DM/DMO Mirzapur for necessary action.

3. Letter of DM Kaushambi regarding appeal 263/2018 and appeal 264/2018.

SEIAA gone through the letter of DM Kaushambi regarding Hon'ble NGT order in appeal number 263/2018 and appeal number 264/2018 and through which the DM has requested for necessary action regarding the above. SEIAA observed that SEIAA/SEAC have already taken decision in this regard in a joint meeting held on 23/10/2019 which is as follows:-

"It came to the notice that after declaration of Hon'ble NGT order dated 25/09/2019 related to Appeal No. 263 of 2018 and with Appeal No. 264 of 2018 : Amit Upadhyay Vs State Level



Environment Impact Assessment Authority and Ors. Member Secretary, State Level Environment Impact Assessment Authority has already sent letter for the compliance of the Hon'ble NGT order dated 25-09-2019 to DGM, UP and to the respective District Magistrates. Vide letter no. 297/Parya/SEIAA/ Appeal No. 263 & 264 of 2018/NGT Compliance/18 dated 19 October, 2019. In the Joint meeting the following operative para of the order was discussed:-

...*"For the aforesaid reasons, we hold unhesitatingly that the ECs granted to all the mining leases fail to satisfy the requirement of the EIA Notification 2006, directions issued by the Hon'ble Supreme Court in Deepak Kumar (supra), the Sustainable Sand Mining Management Guidelines, 2016 and the various Office memorandums issued by the MoEF&CC in relation thereto. The ECs, therefore, deserve to be quashed and is accordingly ordered so."*

It was unanimously decided that all the concerned 36 ECs in question may be revoked immediately by the SEIAA to comply Hon'ble NGT order." SEIAA instructed Nodal SEIAA to take necessary action for issuance of order in this regards.
