## Minutes of the 312th Meeting of the State Level Environment Impact Assessment Authority, UP (SEIAA) held on 18/10/2019

The meeting of 312<sup>th</sup> State Level Environment Impact Assessment Authority, UP (SEIAA) was held on 18/10/2019 at the Directorate of Environment. The following were present in the meeting:-

General- SEIAA noted that minutes of the public hearing received from UPPCB office sometimes does not have photocopies of both the News Paper cuttings of notices publish. Hence SEIAA decided that Nodal officer SEIAA should write a letter to UPPCB that photocopies of two News Paper cuttings of the notices published in the News Papers shall also be sent with the minutes of public hearing meeting.

SEIAA noted that above project was taken in its meeting dated 1/08/2019 in which SEIAA observed that the project proponent has applied for expansion under violation category. Certified compliance report of previous EC has not been submitted. Waste water generated is mentioned as 165 KLD whereas STP of 100 KLD is being proposed which is under capacity. The water balance for monsoon and non-monsoon season should be recalculated. Information submitted regarding remediation plan and its implementation is not very clear. Structure stability measures taken care for the revision plan is also not clear. Hence SEIAA opined that the project proponent shall be called to make a presentation of the project before SEIAA.

The project proponent along with the consultant presented their case. During presentation SEIAA found that the project proponent has proposed to install STP of 100 KLD and the water balance submitted mentions that 90 KLD untreated sewage will be discharged to municipal sewer line for further treatment by GDA but has not submitted any MOU/consent letter/agreement signed with GDA in this regard. Project proponent has not submitted certified compliance report from MOEF&CC which is necessary for expansion. Hence SEIAA opined that the project proponent shall submit the above information along with the relevant documents. KPSiph

- 6- The project proponent shall ensure that waste water is properly treated in STP and maximum amount should be reused for gardening flushing system and washing etc. For reuse of water for irrigation sprinkler and drip irrigation system shall be installed and maintained for proper function. Part of the treated sewage, if discharged to sewer line, shall meet the prescribed standards for the discharged. Under any circumstances untreated sewage shall not be reused or discharged to municipal sewer line.
- 7- The project proponent will ensure that proper dust control arrangements are made during construction and proper display board is installed at the site to inform the public the steps taken to control air pollution as per the Construction and Demolition Waste Management Rules.
- 8- The project proponent shall install micro solar power plants, toilets in nearby villages, public place or school from CER fund of the project for which E.C is granted in addition to and water harvesting pits and carbon sequestration parks / designed ecosystems.

The SEIAA noted that the above matter regarding EC requirement in various expressway, National/State Highway District/villages roads and, other government projects was taken in its meeting dated 14/10/2019 wherein, SEIAA went through the note dated 11/10/2019 submitted by members and Chairman, SEAC regarding letter no. 968/M-21/NHAI-2/2017 dated 07 September 2019 of Director Geological and Mining UP and letter no. 1104/V.Sh.(Khanan)/2019 date 09/08/2019 of DM Lucknow noted that EC has been granted vide MoEF notification 141(a) annexure-9 point no. 5 which states that:-"Community works like desilting of village ponds or tanks, construction of village roads, ponds, bunds undertaken in Mahatama Gandhi National Rural Employment and Guarantee Schemes, other Government-sponsored schemes, and community efforts". After this notification, no other amendment regarding the above has been issued. Hence the above works do not require Environmental Clearance.

SEIAA reviewed the matter and came across Hon'ble National Green Tribunal Principal Bench, New Delhi order, passed in Executive Application No. 55/2018 IN Original Application No. 520/2016:Vikrant Tongad Versus Union of India Dated: 11.12.2018 and thus reviewed the matter in the light of the operative para of the aforesaid order wherein it is stated that:

"...6. Since our attention has been drawn to letter dated 29.10.2018 issued by the State Environment Impact Assessment Authority, Kerala addressed to the District Environment Impact Assessment Authorities of various districts in Kerala that Notification dated 15.01.2016 having not being stayed, the same be followed. This interpretation is clearly contrary to the order of this Tribunal disapproving the Notification dated 15.01.2016 and requiring the same to be revised. The direction that 15.01.2016 should still be acted upon is clearly illegal and in violation of judgment of this Tribunal. The same will stand suspended till a fresh Notification is issued by the MoEF&CC as directed hereinabove.

7. This direction will apply to all the State Environment Impact Assessment Authorities/State Governments.

SEIAA also noted that Ministry of Environment, Forest & Climate Change vide OM no. F.No. L-11011/175/2018-IA-II (M) dated: 12-12-2018 has issued the directions for only:-

- (i) Providing for EIA, EMP and therefore, Public consultation for all areas from 5 to 25 ha falling member Category B-2 at par with Category B-1 by SEAC/SEIAA as well as for cluster situation wherever it is not provided;
- (ii) Form-1M be made more comprehensive for areas of 0 to 5 ha by dispensing with the requirement for Public Consultation to be evaluated by SEAC for recommendation of grant EC by SEIAA instead of DEAC/DEIAA;
- (iii) If a cluster or an individual lease size exceeds 5 ha the EIA/EMP be made applicable in the process of grant of prior environmental clearance;
- (iv) EIA and/or EMP BE PREPARED FOR THE ENTIRE CLUSTER IN TERMS OF RECOMMENDATION 5 (SUPRA) of the Guidelines for the purpose of recommendations 6, 7 and 8 thereio;
- (v) Revise the procedure to alos incorporate procedure with respect to annual rate of replenishment and timeframe for replenishment after mining closure in an area;
- The MoEF&CC to prepare guidelines for calculation of the cost of restitution of (vi) damage caused to mined-out areas along with the net present Value of Ecological Services forgone because of illegal or unscientific mining;

In the view of the above, SEIAA is of the opinion that Copies of Hon'able National Green Tribunal Principal Bench, New Delhi order, passed in Executive Application No. 55/2018 IN Original Application No. 520/2016:Vikrant Tongad Versus Union of India Dated: 11.12.2018 and Ministry of Environment, Forest & Climate Change Impact Assessment Division vide OM no. F.No. L-11011/175/2018-IA-II (M) dated: 12-12-2018 should be sent to MoEF&CC for clarification/guidance. Till then the decision of the SEIAA regarding the above matter taken in its meeting dated14/10/2019 is kept in abeyance.
