The meeting of 319th State Level Environment Impact Assessment Authority, UP (SEIAA) was held on 20/11/2019 at the Directorate of Environment. Since the minutes of the meeting are yet not final/signed SEIAA reviewed the cases again on 23/11/2019 in light of Hon'ble NGT order passed in O.A. no. 1038/2018 dated 14/11/2019 (corrected on 19/11/2019). General Discussion:-


SEIAA secretariat has provided a copy of Hon'ble NGT order passed in O.A. no. 1038/2018 dated 14/11/2019 (corrected on 19/11/2019) directing the mechanism circulated by CPCB for Environmental Management of critically polluted areas (CPA) and severely polluted area (SPA) for orange and red category of polluting industries to be followed, which states that:-

1. Any project or activity specified in category B1 will be appraised at the central level, if located in whole or in part within 5 kilometres from the boundary of critically polluted areas or severely polluted areas. However, Category B2 projects shall be considered at state level stipulating Environment Clearance conditions as applicable for the category B1 projects/activities.
2. Proposals located in CPAs and SPAs may be examine by the sectoral Expert Appraisal committee (EAC) during scoping/appraisal based on the CEPI scores of air/water/land environment as published by CPCB from time to time. In such proposals, appropriate mitigation measures for the environment possessing higher CEPI score may be made by EAC in the form of recommendations/decision. These recommendations may be explicitly mentioned in the terms of reference/ Environmental Clearance letter and to be ensured by the member secretary concerned.

SEIAA gone through the available documents and noted that some areas of 13 districts of UP are kept under CEPI. SEIAA noted that area concerned within the district is not clear/ demarcated and also list of red and orange category of polluting industries for which Hon'ble NGT order are applicable is not available. Hence SEIAA

opined that Nodal SEIAA shall obtain a complete CEPI report and also the list of polluting industries from MoEF&CC as early as possible.

SEIAA also opined that the cases of these 13 districts would be reviewed later and decision would be taken after clarification from MoEF&CC.

SEIAA opined that the project proponent should now apply accordingly and SEAC shall appraise the cases accordingly.

The SEIAA agreed with recommendation of SEAC that the matter will be discussed only after submission of request on prescribed online portal.




