## Minutes of 611th SEAC-2 Meeting Dated 23/12/2021

 "Affordable Rental Housing Scheme" at Khasra No.- Nil, Deoghat, Jalwa Scheme Allahabad., Shri Saumitra Kumar, R/o-Refineries Division, Core 2, M/s Indian Oil Corporation Limited. File No. 6596/Proposal No. SIA/UP/MIS/229830/2021

SEIAA noted that SEAC has recommended to grant EC to the above project. SEIAA gone through file, documents and opined that project proponent shall submit NOC from CGWA for using ground water during construction phase, NOC from Airport Authority. SEIAA noted that 253 KLD of waste water is being generated whereas STP capacity of 255 KLD is being installed which is inadequate, hence proposal for STP of adequate capacity should be installed, proposal for 33% tree cover should be submitted. Project Proponent / consultant should submit information on above mentioned issues to concerned SEAC-2 for evaluation.

 Group Housing Project "Apex The Rio" at Khasra No.- 526/2, Village-Kanawni(V), Ahinsa Khand -II, Ghaziabad., M/s Rio Heights Pvt. Ltd. File No. 4981/Proposal No. SIA/UP/MIS/ 113366/2019

SEIAA noted that SEAC has recommended to change the address from Khasra No.-526/2 to Khasra No.-526/1M. SEIAA gone through file and documents and found that the proposal was made for Khasra No.-526/2. Hence SEIAA opined that an inspection of the above project be made by Mr. T.U. Khan, Member SEAC-2 and RO UPPCB, Ghaziabad.

3. Assembling of Led Lights & Components at Plot No.-10, Sector-156, Noida, M/s Ikio Solution Pvt. Ltd. File No. 6328/Proposal No. SIA/UP/MIS/ 211400/2021

SEIAA noted the comments of SEAC that the committee went through the replies submitted by the project proponent and found it satisfactory. Hence, the committee recommended grant of environmental clearance for the project proposal along with environmental clearance conditions earlier stipulated in 553rd SEAC meeting dated 29/07/2021. SEIAA opined that the queries raised are not replied satisfactorily. Hence SEIAA opined that the project proponent shall submit the replies again.

- Proposal for 33% tree cover should be submitted at the time of EIA/EMP.
- Solar power to be used for lightning to reduce power load on grid.
- 3- Separate meter shall be installed for solar power.

- 4- Solar power should meet 20% of demand of building or as per local building by laws whichever is higher.
- 5- All pages of technical documents/EIA/EMP etc. should be signed by the consultant and project proponent both.
- 6- Copy of all the analysis reports duly signed by analyst approved by NABL or MoEF&CC shall be annexed with the EIA report and original analysis reports should be presented at the time of presentation.
- 7- MOU signed between the project proponent and the consultant should be submitted.
- 8- A certificate from Forest Department shall be obtained that no forest land is involved and if forest land is involved the project proponent shall obtain the forest clearance and permission of Central and State Government as per law under the provisions of Forest (conservation) Act, 1980 and submit along with EIA.
- 9- Public hearing shall be conducted as per EIA notification, 2006 (as amended).
- 10-SEIAA opined that the project proponent shall submit permission of CGWA or proposal for alternative source of fresh water.
