# MINUTES OF THE 100<sup>TH</sup> GOA STATE ENVIRONMENT IMPACT ASSESSMENT AUTHORITY (GOA-SEIAA) MEETING HELD ON 21/04/2023 AT 03:30 P.M. IN THE CONFERENCE ROOM OF THE 4<sup>TH</sup> FLOOR, DEMPO TOWER, PATTO, PANAJI-GOA
