Note:Submit a copy of each of above documents - <u>Hard and Soft</u> <u>Copies (CD) to the Member secretary, Violation (Note: Not by Name)</u> by speed post so as to reach well in time. (ii) Compliance Report from Regional Office, MoEF&CC (Applicable for projects already having EC).

- (iii) The KML/Shape files should be emailed to mentioned at para No. 7
 below at least 5 days prior to the meeting.
- (iv) The above all documents are required to be forwarded to the Chairman/Members of the Expert Appraisal Committee along with soft copy.
- 2 All the documents including the hard copy of the presentation material should be legible and printed on both sides on ordinary paper. In case the members of the Expert Appraisal Committee do not receive the proposals/documents before the meeting, the Committee will not consider the project.
- 3 The Project Proponent or his or her authorized representative /consultant <u>should avoid delivery of documents by hand and seeking</u> <u>meeting with Chairman/Members.</u> Members are also requested to discourage/ avoid the meeting with the PP/ consultants.
