#### BACKGROUND

Earlier multiple applications were received at SEIAA under the provisions of Notification S.O. 804(E) dated 14.03.2017 and SoP dated 07.07.2021. SEIAA has disposed off a portion of such applications as per the SOP dated 07.07.2021. However, multiple applications are pending at the level of project proponents (Delisted) while some are pending at SEIAA as listed in serial no. 1 to 4. The projects were pending at SEIAA because the Hon'ble Supreme Court stayed the SOP vide Order dated 02.01.2024 in WP 1394/2023. The final order of the Hon'ble Supreme Court came on 16.05.2025 wherein the Hon'ble Supreme Court struck down the Notification S.O. 804(E) dated 14.03.2017 and SoP dated 07.07.2021.

Subsequently, SEIAA wrote to MoEF&CC vide letter no.1148/EN/T-II-1/077/2012 (Pt-II) dated 11.06.2025 seeking clarification whether SEIAA is required to reject the violation cases or otherwise. No reply has been received till date.

# **DELIBERATION IN SEIAA**

SEIAA observed that Hon'ble Supreme Court has struck down the Notification S.O. 804(E) dated 14.03.2017 and SoP dated 07.07.2021. Hence there is no provision for SEIAA/SEAC to process any of the violation projects any more. Therefore, SEIAA decided to reject all violation projects lying at its end.

# RECOMMENDATION OF SEIAA

Applications for EC are rejected for 1 to 4.

### **CONCLUSION**

Rejected.
