1. Sand/Morrum Mining from betawa river for M/s Suresh Chandra Gupta at Gata No. 596 Khand No. 1, Village- Basrehi, Tehsil- Kalpi, District- Jalaun, U.P. (Area 16.194ha) File no- 4089/Proposal No. (SIA/UP/MIN /72828/2018)

SEIAA gone through the letter of Shri Saurabh Gupta, dated 17.08.2020 regarding transfer of Environmental Clearance to the above project issued vide letter no. 232/Parya/SEAC/4089/2018 date 16.03.2018. SEIAA gone through the file and documents and found that the above Environmental Clearance was issued to Shri Suresh Chandra Gupta S/o Shri Narayan Das Gupta, House no. 60, Ganesh Bazar, Jhansi. SEIAA noted that the previous lease issued to Shri Suresh Chandra Gupta was cancelled vide DM, Jalaun order no. 61/Khanij/MMC30 dated 25.04.2019 and another Lol was issued to Shri Saurabh Gupta S/o Shri Urmila Charan Gupta, 944, Civil lines, Jhansi vide letter no. 377/30MMC/2020-21 dated 18/06/2020. Hence SEIAA opined to transfer Environmental Clearance issued vide letter no. 232/Parya/SEAC/4089/2018 date 16.03.2018 from Shri Suresh Chandra Gupta S/o Shri Narayan Das Gupta, House no. 60, Ganesh Bazar, Jhansi to Shri Saurabh Gupta S/o Shri Urmila Charan Gupta, 944, Civil lines, Jhansi with the condition that the EC will not be transferred further and after 6 months the EC will be null and void. Rest all the content of Environmental Clearance letter shall remain the same.

SEIAA gone through the letter of Shri Vichitra Singh dated 28.08.2020 regarding objection and service of notice on wrong EC granted for the above area. SEIAA opined to refer the letter to SEAC for comments/recommendation.

SEIAA gone through the letter of Shri Rajesh Mishra dated 17.08.2020 regarding issuance of Lol of gata no. 91-94, 115-122 and 123-127 of Village Lilara, Fatehpur. As the matter pertains to DM, SEIAA opined to refer the letter to DM Fatehpur for necessary action.

4. Sand/Morrum Mining from Ken Riverbed at Gata No. 165, 166 and 174, Block No. 20 at Village padohra Khadar, Tehsil Pailane, & District Banda, Uttar Pradesh. (Area 14.0 Ha). File No. 4428/Proposal No. SIA/UP/MIN/76021/2018

SEIAA gone through the letter of Shri Arvind Singh Sikarwar, Morena, MP dated 20.08.2020 regarding transfer of Environmental Clearance to the above project issued vide letter no. 479/Parya/SEAC/4428/2018 date 22.11.2018. SEIAA gone through the file and documents and found that the above Environmental Clearance was issued to Shri Bashudev Sharma S/o Shri Kanhaiya Lal Sharma, Surajpura, Nakhloli, Atar, Bhind, MP. SEIAA noted that the previous lease issued to Shri Bashudev Sharma was cancelled vide DM, Banda order no. 1694/Khanij-30/Banda dated 24.09.2019 and another Lol was issued to Shri Arvind Singh Sikarwar, S/o Shri Ram Singh Sikarwar, 28/199, New Gandhi Colony, Morena, MP vide letter no. 943/Khanij-30/Banda dated 01.07.2020. Hence SEIAA opined to transfer Environmental Clearance issued vide letter no. 479/Parya/SEAC/4428/2018 date 22.11.2018 from Shri Bashudev Sharma S/o Shri Kanhaiya Lal Sharma, Surajpura, Nakhloli, Atar, Bhind, MP to Shri Arvind Singh Sikarwar, S/o Shri Ram Singh Sikarwar, 28/199 New Gandhi Colony, Morena, MP with the condition that the EC will not be transferred further and after 6 months the EC will be null and void. Rest all the content of Environmental Clearance letter shall remain same.

5. Building Stone (Khanda, Gitti & Boulder) Mine at Gata No.-1073, (Khanda No.-03), at Village-Jarar, Tehsil-Naraini, Banda., M/s Malhotra Brothers, Area -2.0 ha. File No. 5497/4834/Proposal No. SIA/UP/MIN/50578/2019

SEIAA gone through the letter of Shri Habeebburrahman and Shri Javed Iqbal dated 26.08.2020 regarding grant of the EC wrongly to the above project. SEIAA opined to refer the letter to SEAC for comments/recommendation.

SEIAA gone through the letter of Shri Surendra Singh, Mirzapur, dated 25.08.2020 regarding the above subject. SEIAA opined that the letter shall be sent to SEAC for comments.

7. Sand/Morrum Mining at Betwa River Bed, Gata No.- 1191/2, Khand No.- 03, Village-Sikarivyas, Tehsil- Orai, District- Jalaun, U.P., Shri Raghvendra Singh. (Lease Area 20.20 Ha) File No. 4119/Proposal No. (SIA/UP/ MIN /73216/2018)

SEIAA gone through the letter of Shri Vinod Kumar Rai, Jhansi dated 14.08.2020 regarding transfer of Environmental Clearance to the above project issued vide letter no. 73/Parya/SEAC/4119/2018 date 14.05.2018. SEIAA gone through file and documents and found that the above Environmental Clearance was issued to Shri Raghvendra Singh S/o Shri Devi Prasad, Village & Post – Bijaura, Thana- Todi Fatehpur, Tehsil- Garautha, Jhansi. SEIAA noted that the previous lease issued to Shri Raghvendra Singh was cancelled vide DM, Jalaun order no. 429/Khanij/30MMC dated 22.08.2019 and another Lol was issued to Shri Vinod Kumar Rai M/S Anuradha Construction, 1962/2 Shahni Compound Civil lines Jhansi vide letter no. 1207/30MMC(E-tender 2020 dated 17/06/2020. Hence SEIAA opined to transfer Environmental Clearance issued vide letter no. 73/Parya/SEAC/4119/2018 date 14.05.2018 from Raghvendra Singh S/o Shri Devi Prasad, Village & Post – Bijaura, Thana- Todi Fatehpur, Tehsil- Garautha, Jhansi to Shri Vinod Kumar Rai M/S Anuradha Construction, 1962/2 Shahni Compound Civil lines Jhansi with the condition that the EC will not be transferred further and after 6 months the EC will be null and void. Rest all the content of Environmental Clearance letter shall remain same.

8. Proposed FWS Logistic Park at Gata No.- 847 and 848, Village- Sikandrabad Dehat, Tehsil - Sikandrabad, District- Bulandshahar, U.P., M/s VRY Logistic Park LLP. File No. 4436/Proposal No. SIA/UP/NCP/76075/2018

SEIAA gone through the letter of the project proponent dated 06.08.2020 regarding inclusion of two gata in issued Environmental Clearance dated 23.01.2019. SEIAA noted that the Environmental Clearance was granted on the basis of SEAC recommendation. Hence SEIAA opined that the matter shall be referred to SEAC for review/comments.

9. Proposed Riverbed Sand/Morrum Mining Project from Ken River of M/s Eureka Mines and Minerals LLP located at Gata No.-747 (Khand No.- 01), Village- Pathreta, Tehsil- Kalpi, District-Jalaun, Uttar Pradesh. Sanctioned Lease Area-40.02 Ha File No. 4512 / 4384/Proposal No. SIA/UP/MIN/29419/2018

SEIAA gone through the letter of Shri Vinod Kumar Rai, Jhansi dated 13.08.2020 regarding transfer of Environmental Clearance to the above project issued vide letter no. 501/Parya/SEAC/4512-4384/2018 date 24.11.2018. SEIAA gone through the file and documents and found that the above Environmental Clearance was issued to Shri Chandra Shekhar Chaurasia S/o Shri Deen Dayal Chaurasia, Lucknow. SEIAA noted that the previous lease issued to Shri Chandra Shekhar Chaurasia, Lucknow was cancelled vide DM, Jalaun order no. 1033/khanij-30MMC dated 23.03.2020. SEIAA also gone through the letter of project proponent dated 10.09.2020 requesting to withhold the transfer of EC annexing Commissioner Court – Jhansi Order dated 02.09.2020. Hence SEIAA opined to refer the matter to DM Jalaun for further necessary action.

SEIAA gone through the letter of Shri Pramod S/o Shri Ranjeet, Saharanpur dated 22.08.2020 regarding the above matter. SEIAA opined to refer the letter to SEAC for comments/recommendations.

11. Reporting Violation of N.G.T. Order in File No. 4416, reporting illegal mining by Pockland Machines, Reporting Illegal Mining happening in Monsoon Period.

SEIAA gone through the letter of Shri Vijendra Singh S/o Shri Holdi Singh Aligarh dated 11.08.2020, along with show cause notice dated 29.06.2020 issued by DM Shamli, addressed to the project proponent (Copy attached). SEIAA noted that complaint regarding above was received earlier too. Hence SEIAA opined to refer the matter to DM Shamli for necessary action and the latest factual report.

12. Proposed Jaypee Greens, Sports City East Part I & II, Sector- 19 & 22, District-Gautam Buddha Nagar, U.P., M/s JaypeeInfraTech Limited. File No. 5528/Proposal No. SIA/UP/NCP/50900/2020

SEIAA noted that the above project was taken in its meeting dated 19.06.2020 in which SEIAA noted that it is not clear whether the present project proposal is for amendment, revision, expansion or new Certified Compliance Report of MoEF&CC for the previous EC is also not available in file. SEIAA directed the Nodal Officer to put up the complete file along with all the documents as and when made available by project proponent and place it to the next meeting. The project proponent has submitted documents. SEIAA agreed with the recommendation of the SEAC to issue the additional ToR;s to the title proposal for conducting EIA studies. The SEIAA also added the following points to TOR;-

- 1- All pages of technical documents/EIA/EMP etc. should be signed by the consultant and project proponent both.
- 2- Copy of all the analysis reports duly signed by analyst approved by NABL or MoEF&CC shall be annexed with the EIA report and original analysis reports should be presented at the time of presentation.
- 3- MOU signed between the project proponent and the consultant should be submitted.
- 4- The project proponent shall obtain the forest clearance and permission of Central and State Government as per law under the provisions of Forest (conservation) Act, 1980 and submit along with EIA.
- 5- Public hearing shall be conducted as per EIA notification, 2006 (as amended).
- 6- If the proposed project falls in Critically Polluted Areas (CPAs), Severely Polluted Areas (SPAs) the provision of the mechanism framed regarding compliance of Hon'ble NGT order in OA 1038/2018 dated 19-08-2019 by MoEF& CC, Govt. Of India vide letter dated 31-10-2019 shall be followed in letter and spirit.
- 7- All the additional condition for grant of Consent to Establish (CTE)/Consent to Operate (CTO) related to Pollution mitigation measures as prescribed in the office memorandum of MoEF&CC, GoI dated 31.10.2019 and as deemed fit by UP Pollution Control Board in the consent orders shall be followed by Project Proponent.
- 8- SEIAA opined that the project proponent shall submit permission of CGWA or proposal for alternative source of fresh water.

13. Tannery Project (from Raw to Finish leather) at Plot No.- B-11/C and B-11/D at Site -II UPSIDC (Near Dahi Chauki), District- Unnao, U.P.,M/s Omega International Unit- IV File No. 4619/Proposal No. SIA/UP/IND/30526/2018

SEIAA noted that the above matter was considered in its meeting dated 02-09-2020 in which SEIAA instructed nodal SEIAA to put up the old file in the next meeting for discussion. Nodal SEIAA informed that old file is not traceable. SEIAA noted that the

above project was taken in its meeting dated 02.04.2019 in which gone through the recommendation of the SEAC to issue ToR;s. as well as the the file and documents and noted that the project was issued ToR;s earlier vide letter no.1712/PARYA/SEAC/2421/2014 dated 03-11-2014. SEIAA noted that after more than 4 years the project proponent has submitted the application for issuance of new/amended ToR. As the records related to earlier issuance of TOR is not available, SEIAA opined that the project proponent shall submit all the relevant documents submitted earlier for the records of SEIAA. After going to file and documents submitted for the new TOR, SEIAA also noted that the project report for waste water treatment plant is submitted mentioning Green Enviro Engineers Pvt. Ltd, Kanpur (no address mentioned) as consultant. Neither NABL accreditation documents nor MOU signed with consultant have been submitted. During presentation before SEAC the project proponent has mentioned Sri Hari Om Dwivedi, as consultant to make presentation before SEAC. None of the technical documents has been signed by any of the consultants. Hence SEIAA opined that the project proponent shall submit clarification in this regard along with all the relevant documents.

14. Construction of IT-SEZ at Plot No. 8, Sector-144, Noida, U.P. M/s Golden Tower Infratech Pvt. Ltd. File No. 670/Proposal No. SIA/UP/MIS/ 151595/2020

SEIAA gone through the letter of the consultant dated 28.07.2020 regarding the above project in relation to the addition of amendment letter dated 26.09.2018 in the validity extension of Environmental Clearance letter dated 04/07/2011 for the period of 01 year. SEIAA gone through the file and documents and found that an amendment was issued vide letter no. 367/Parya/SEAC/670/2016 dated 26.09.2018. Hence SEIAA opined to refer the letter to SEAC for comments/recommendation.

15. Expansion of Group Housing at Khasra No.1104m, 1111m, 1116m & 1123m, Village-Noor Nagar, Loni, NH-55, Raj Nagar Extension, Ghaziabad, M/s LR Infrahomes India Pvt Ltd. (File no-3858)

SEIAA noted that the above project was taken in its meeting dated 14.08.2020 in which SEIAA agreed with the recommendation of the SEAC dated 15.05.2019 to grant the prior Environmental Clearance to the proposed project. SEIAA reviewed the case and gone through the file, documents and NOC of Ministry of Defence dated 07.02.2014. SEIAA added one specific condition:-

- 1- Conditions of NOC granted by Ministry of Defence vide letter no. Air HQ/S17726/04/ATS (PC-MCCCXCV) dated 07.02.2014 shall be strictly followed.
