1. EC forOrdinaryEarth "KhtaparaPatta LandOrdinary earth MPA" under Aie Valley Division, Bongaigaon by Shahi Md. Karim. SEIAA.1194/2020 (Proposal no. SIA/AS/MIS/139422/2020)

SEAC Resolution 5/2:

The documents furnished along with the project proposal have been scrutinized and after due discussion, the committee *approved* the project and *recommended* for issue of EC allowing to excavate 50,158cum Ordinary Earth for 2 (two) years time i.e. 25,079cum annually. The mining should be done strictly following the statutory conditions laid down by the Geology and Mining Department, Assam. The DFO, Aie Vally Division will ensure monitoring of mining from time to time to avoid irregularities in mining operation.
