The Authority after detailed discussion and deliberation decided the following:

- 1. Serial No. 1:** Proposal was deferred in the 5.62<sup>nd</sup> meeting and then closed and delisted in the 5.72<sup>nd</sup> meeting of SEIAA (27.04.2023) *due to non-submission of valid lease documents*. Now, PP has submitted the executed lease deed dated 20.07.2023. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to this proposal.
- 2. Serial No. 2:** SEAC had recommended to close and delist the proposal on the ground that *"The Committee observed that as per WRD certificate Khari River is at a distance of 30 meters and as per KML file, a tributary of Khari River is passing/traversing through the applied area. In view of the above Committee deliberated that mining activity would adversely affect the course of water"*. PP had submitted a representation in SEIAA against the recommendations of SEAC, based on which the Authority in its 5.84<sup>th</sup> meeting referred back the proposal to SEAC. Subsequently, SEAC examined the proposal again and noted that the WRD Certificate dated 14.02.2023 has been issued without regard to the fact that the WR Department does not have record of HFL for return period of 25 years and that the presence of natural nallah at 16 m from the lease boundary has not been mentioned in the Certificate. Based on these observations, SEAC reiterated its decision to recommend to reject and close and delist the proposal. Subsequent to SEAC's reiteration of its earlier decision, the Authority considered the case in its 5.101<sup>st</sup> meeting and *"directed the PP that the observations of SEAC may be conveyed to WRD and PP may submit a final NOC from the WR Department in this regard."* Now, PP has submitted the final NOC from the Water Resource Department vide letter dated 20.09.2023. WRD in its letter has not submitted any objection to the proposed mining area. WRD is the competent Authority to determine whether the mine would impact the natural drainage in the area or not. Moreover, WRD has also categorically mentioned in its certificate dated 14.02.2023 that the



applied area doesn't infringe with the directions of Hon'ble HC in the matter of Abdul Rehman and has given its consent subject to certain conditions.

In these circumstances, there appears no proper justification given by SEAC to object to the mining activity in the proposed area and to recommend for rejection of the proposal. The objection of SEAC on this ground alone is over-ruled by SEIAA and this decision shall be final as per para 8 (ii) of EIA Notification, 2006.

Matter may be **referred back to SEAC** to examine the proposal on technical grounds and give its recommendations in respect of grant of EC on other technical points along with any specific conditions proposed, if any. In doing so, SEAC shall not re-consider the aspect of submergence, flood plain area etc, which has now been decided upon.

3. **Serial No. 3:** Proposal was deferred in the 5.102<sup>nd</sup> meeting of SEIAA for *submission of ATR of non-complied conditions of CCR and revised Aravalli certificate with correct khasra numbers.*

Now, PP has submitted ATR for non-compliance in CCR along with revised Aravalli certificate with correct Khasra numbers. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to this proposal.

4. **Serial No. 4:** Proposal was deferred in the 5.100<sup>th</sup> meeting of SEIAA for detailed AV presentation and then proposal was again deferred in the 5.102<sup>nd</sup> meeting of SEIAA for the following reasons:

- *Plot B – The Authority had concerns in respect of activities proposed in Plot B. There were no details in the Conceptual Plan submitted in respect of the Convention Centre with a projected population of 4500. The parking provisions for the Flexi Offices were considerably inadequate.*
- *In addition, it was felt that PHED water supply may not be able to supply the entire 669 KLD requirement of fresh water for the complex and the PP needs to apply for ground water supply source from CGWA.*

PP was heard during the meeting and on behalf of PP, it was informed that the seating capacity of the proposed Convention Centre is 2632, in place of 4500 stated earlier, the offices proposed are corporate offices and not the dense sitting

staff. Further, most hotel guests would not require parking as also delegates for the Convention Centre, most of them being outstation and this being situated at the airport itself. In addition, PP suggested that in course of detailed planning and execution of the project, provisions would be made in such a manner that the spill over of excess vehicles during any particular event, would be accommodated on internal roads and other open areas as feasible and that no spill over of vehicles would be allowed to go to the main Tonk Road outside. PP had also submitted a written reply to all the concerns raised by the Authority earlier. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to this proposal.

5. **Serial No. 5:** Proposal was deferred in the 5.101<sup>st</sup> meeting of SEIAA for "*submission of ATR of non-complied conditions of CCR and certified production figures*". Now, PP has submitted requisite documents. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to grant Amendment in EC to this proposal.
6. **Serial No. 6:** Proposal was deferred in the 5.101<sup>st</sup> meeting of SEIAA (03/11/2023) as "*in this proposal, Block B of the mining lease at a distance of 10 m from the nearest forest boundary as per topo-map and 8 m as per KML submitted by PP and whereas the State Govt. order dated 14.06.2023 has specified minimum distance for mining as 50 m or more from the nearest forest boundary. Proposal was deferred and PP may be afforded an opportunity of personal hearing to explain why the permission shall not be denied for mining activity in Block B, as nearest forest is at less than 50 m from the forest boundary.*"  
PP was heard and has submitted revised block- wise separate certificates issued by DCF, Dholpur vide letters dated 29.11.2023 wherein as per DCF Certificate, all three blocks are clearly at a distance of more than 50m from the closest forest boundary. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to this proposal.
7. **Serial No. 7:** Proposal was deferred in the 5.101<sup>st</sup> meeting of SEIAA for "*submission of ATR of non-complied conditions of CCR*". Now, PP has submitted requisite documents. Hence, The Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP and grant EC to this proposal with the condition that PP shall also



ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

8. **Serial No. 8:** Proposal was deferred in the 5.102<sup>nd</sup> meeting of SEIAA held on 09.11.2023 for the following reasons:

- *Cluster Certificate expired on 19.10.2022*
- *Production figures 2022-23 were not available in the proposal.*
- *CCR is more than one year old.*

Now, PP in his reply submitted vide letter dated 14.12.2023 has stated that:

- Cluster Certificate dated 07.12.2023 is submitted. (No cluster formation as lease was registered before 09.09.2013)
- Production figures vide letter dated 07.12.2023 has been submitted. (2022-2023 NIL)
- CCR was valid during SEAC meeting 27.04.2022, hence it is valid. (reference given OM dated 08.06.2022)

The Authority found the reply satisfactory. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to this proposal.

9. **Serial No. 9:** Proposal was deferred in the 5.102<sup>nd</sup> meeting of SEIAA for *submission of Transfer EC in the name of applicant.*

Now, PP has submitted the reply which was found satisfactory. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to this proposal.

10. **Serial No. 10: Proposal was deferred in the 5.104<sup>th</sup> meeting of SEIAA as in this proposal, "As per approved Building Plan, permission has been granted for construction of 2B+2S+G+6 floors with 42 flats whereas PP has proposed construction of 2B+2S+G+14 with 90 flats. Also as per approved Building Plan, 10 % of total parking has to be reserved for EV Charging Facilities but the same has not been incorporated in the proposal. Proposal was deferred for presentation by PP to explain the proposal"**

PP was heard during the meeting and the Authority found all the replies as put forth by the PP to be satisfactory. Hence, the Authority accepted the

recommendations and additional conditions of SEAC and decided to **grant EC** to this proposal.

**11. Serial No. 11, 28, 43, 46, 61, 65, 69, 77, 78, 79:** The Authority accepted the recommendations of SEAC and decided to **close and delist** these proposals.

**12. Serial No. 12, 26, 29, 31, 32, 33, 39, 40, 44, 45, 48, 49, 50, 53, 56, 57, 62, 63, 68, 70, 71, 72, 75, 76:** The Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to these proposals.

**13. Serial No. 13:** The Authority accepted the recommendations and additional conditions of SEAC and decided to **reject the representation of PP for corrigendum in issued TOR letter** to this proposal.

**14. Serial No. 14:** The Authority accepted the recommendations & additional conditions of SEAC and decided to **approve EIA/EMP and grant EC** to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects and **subject to submission of revised Aravalli certificate with correct Khasra Number.**

**15. Serial No. 15:** The Authority decided to **refer back** this proposal to SEAC due to the following discrepancies:

- As per SEAC abstract, period of violation considered in the proposal is 2015-16, 2018-19 and 2021-22 but as per Production Certificate provided in the proposal, the production has exceeded during the years 2015-16, 2016-17 and 2021-22.
- Production Capacity proposed in proposal (3,95,824 TPA) is more than the Production Capacity approved in the Mining Plan (2,20,00 TPA).
- In submitted CCR, general condition no. 16 is mentioned as not complied. Hence, ATR is required.

**16. Serial No. 16, 23:** The Authority accepted the recommendations & additional conditions of SEAC and decided to **approve EIA/EMP and grant EC** to these proposals with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects and **to comply with the conditions laid down by the Water Resource Department in its certificate.**






17. **Serial No. 17, 19, 22, 24, 51:** The Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP and grant EC to these proposals with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
18. **Serial No. 18:** In this proposal, the proposed Production Capacity for individual as well as for Cluster is more than the Production Capacity approved in the Mining Plan and Cluster Mining Plan. Hence, Authority accepted the recommendations and additional conditions of SEAC and decided to approve EIA/EMP for 7,56,956 TPA (ROM) and grant EC for 1,35,755 TPA (ROM) as mentioned in the approved Mining Plan and Cluster Mining Plan to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
19. **Serial No. 20:** The Authority accepted the recommendations & additional conditions of SEAC and decided to grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects subject to the submission of revised Affidavit with correct Khasra Number.
20. **Serial No. 21:** The Authority decided to defer this proposal and seek clarification from the PP on the following points:
- Production Capacity proposed in proposal (7,23,992 TPA) is more than the Production Capacity approved in the Mining Plan (7,17,397 TPA).
  - Cluster area in TOR letter and Cluster Certificate is 7.2335 Ha. but EIA/EMP report has been prepared for 7.0936 Ha.
21. **Serial No. 25:** In this proposal, the proposed Production Capacity for cluster is more than the Production Capacity approved in the Cluster Mining Plan. Hence, Authority accepted the recommendations and additional conditions of SEAC and decided to approve EIA/EMP for 7,25,308 TPA (ROM) as mentioned in Cluster Mining Plan and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

22. **Serial No. 27:** The Authority accepted the recommendations and additional conditions of SEAC and decided to grant TOR (Cluster area: 8.2038 ha) to this proposal.
23. **Serial No. 30:** The Authority accepted the recommendations and additional conditions of SEAC and decided to grant TOR (violation) with Public Hearing (Cluster area: 28.8097 ha) to this proposal *with the specific condition to submit Certified Production Certificate for year 2022-23 and 2023-24 during the time of final presentation of EC.*
24. **Serial No. 34:** The Authority accepted the recommendations of SEAC and decided to grant Amendment in EC to this proposal.
25. **Serial No. 35:** The Authority accepted the recommendations and additional conditions of SEAC and decided to grant TOR to this proposal *with the specific condition to submit latest authenticated DSR at the time of final EC.*
26. **Serial No. 36:** The Authority accepted the recommendations and additional conditions of SEAC and decided to grant TOR to this proposal subject to the submission of revised Aravalli certificate with correct Khasra Number.
27. **Serial No. 37, 38, 66:** The Authority accepted the recommendations & additional conditions of SEAC and decided to grant EC to these proposals with the condition that PP shall also ensure *to comply with the conditions laid down by the Water Resource Department in its certificate.*
28. **Serial No. 41, 64:** The Authority accepted the recommendations and additional conditions of SEAC and decided to grant TOR (Violation) to these proposals.
29. **Serial No. 42:** The Authority accepted the recommendations and additional conditions of SEAC and decided to grant TOR (Violation) to this proposal *with the specific condition to submit Transfer EC letter at the time of final EC.*
30. **Serial No. 47:** The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to this proposal subject to the deposition of Bank Guarantee of Rs. 13,05,000/- (Refundable) for Remediation Plan and Natural and Community Resource Augmentation Plan and deposition of penalty amount of Rs. 73,502/- (Non-refundable) to RSPCB before the issue of EC. PP shall also ensure to raise a dense plantation in the 7.5 m green belt around the lease area to mitigate the pollution effects and with the specific condition that the Environmental Clearance shall become



operational only after receiving Forest Clearance under the provision of Forest Conservation Act, 1980 and in accordance with the Forest Clearance Guidelines dated 07.07.2021 issued by the MoEF&CC.

31. **Serial No. 52:** In this proposal, the proposed Production Capacity for cluster is more than the Production Capacity approved in the Cluster Mining Plan. Hence, Authority accepted the recommendations and additional conditions of SEAC and decided to approve EIA/EMP for 7,37,715 TPA (ROM) as mentioned in Cluster Mining Plan and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
32. **Serial No. 54:** The Authority decided to defer this proposal on the basis of the following deficiencies:
- As per the certificate dated 17.03.2020, issued by DCF, Bhilwara Rajsamand district falls in 10 km periphery of applied area. Therefore, certificate regarding forest distance from DCF, Rajsamand is also required.
  - Khari River is at a distance of 45 m to 100 m as mentioned in the approved Mining Plan. Hence, WRD certificate is required for the same.
33. **Serial No. 55:** The Authority decided to defer this proposal on the basis of following deficiencies/issues:
- Khasra numbers mentioned in the Aravalli certificate are different from those mentioned in the proposal.
  - DSR for bajri has been submitted in place of granite.
34. **Serial No. 58:** The Authority accepted the recommendations and additional conditions of SEAC and decided to grant Amendment in TOR (Cluster area: 73.4897 ha) to this proposal.
35. **Serial No. 59:** The Authority accepted the recommendations and additional conditions of SEAC and decided to grant TOR (Cluster area: 22.4575 ha) to this proposal.
36. **Serial No. 60:** The Authority accepted the recommendations and additional conditions of SEAC and decided to grant TOR (Cluster area: 25.4497 ha) to this proposal.

37. **Serial No. 67:** In this proposal, the proposed Production Capacity is more than the Production Capacity approved in the Mining Plan. Hence, Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC for 2080 TPA (ROM) as mentioned in Mining Plan** to this proposal.
38. **Serial No. 73:** The Authority accepted the recommendations and additional conditions of SEAC and decided to **approve EIA/ EMP and grant EC** to this proposal subject to the deposition of **Bank Guarantee of Rs 8,70,000 /-** (Refundable) for Remediation Plan and Natural & Community Resource Augmentation Plan and deposition of **penalty amount of Rs. 5,02,287/-** (Non-Refundable) to RSPCB before issue of EC. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects and **to comply with the conditions laid down by the Water Resource Department in its certificate.**
39. **Serial No. 74:** In this proposal, PP has exceeded production from the base year. Hence, this is a case of violation. The Authority accepted the recommendations of SEAC and decided to **reject** this proposal and directs the PP to file a fresh application for TOR under violation on Parivesh Portal.
40. **Serial No. 80:** In this proposal, the proposed Production Capacity is more than the Production Capacity approved in the Mining Plan. Hence, Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC for 36125 TPA (ROM) as mentioned in Mining Plan** to this proposal.
41. **Serial No. 81:** In this proposal, Khasra no. mentioned in the proposal, approved Mining Scheme and Aravalli Certificate are different from those given in earlier EC and Demarcation Report. Hence, the Authority decided to **defer** this proposal for additional information i.e., submission of correct Khasra numbers duly authenticated from the competent Authority.
42. **Serial No. 82, 83:** The Authority decided to **grant Transfer EC** to these proposals.
43. **Serial No. 84 to 90:** The Authority decided to **grant Transfer EC with the condition that the PPs concerned shall apply for TOR under violation within 45 days.** In addition to this, RSPCB must monitor the same and ensure that such application is submitted on the portal within the time provided, in absence of which necessary action be taken to stop production.

44. Serial No. 91 to 109: The Authority decided to grant Transfer EC to these proposals with a direction that since these were the ECs issued by DEIAA, the PPs concerned shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28.04.2023 and Hon'ble NGT order dated 07.12.2022.

45. Additional Agenda No. 1: In this proposal, TOR letter was issued by SEIAA on 16.03.2023 for Cluster area 6.6019 Ha. PP has requested for corrigendum in TOR letter w.r.t Cluster area from 6.6019 Ha. to 6.6049 Ha. as per new Cluster certificate dated 26.09.2023 issued by the Mining Department. Hence, the Authority decided to grant Corrigendum in TOR letter dated 16.03.2023.
