The Member Secretary, SEIAA welcomed the Chairman and the Member of SEIAA. After general introductory remarks by the Chairman, SEIAA, the Committee took up items agenda-wise and reviewed the recommendations of State Expert Appraisal Committee (SEAC). After detailed deliberations & discussions on the recommendations of the SEAC, the SEIAA recorded their decisions on case to case basis as under.

The SEIAA discussed the recommendations of the SEAC in detail. It is noted that the industry obtained CFO order dt.28.05.2016 to manufacture Bulk Drugs and permitted to send the effluents through pipeline to ZLD system at sister concerned unit i.e., Dr. Reddy's Laboratories Ltd., Unit-II (CTO-II) for further treatment and reuse of treated effluent. The Industry is located in Ban area i.e., IDA Bollaram and applied for expansion of manufacturing of Bulk Drugs and proposed to treat the effluents in the ZLD system of sister concerned unit i.e., Dr. Reddy's Laboratories Ltd., Unit-II (CTO-II). However, as per G.O.Ms. No. 64, dt. 25.07.2013 & G.O. Ms. No. 24, dt. 24.04.2019 of the EFS&T Dept., the expansion is permitted subject to installation of ZLD system at the site. Hence, the proposal is rejected as they have not proposed installation of ZLD system at Unit-I.



Ms. No. 24, dt. 24.04.2019 of the EFS&T Dept., and proposed inadequate greenbelt area. Hence, rejected.
