Recommendations of the SEAC on 26.03.2016: The committee reexamined the representatives and observed as follows.

1. The project proponent filed application through the online. All documents are in public domain.

2. SEAC and SEIAA have examined the project proposal in detail and incorporated series of conditions in the EC order to safeguard the environment.

3. A condition was stipulated in the EC Order that the proponent shall comply all conditions applicable for this project in the EC Order issued to the Capital City.

4. As per EIA notification, 2006 construction projects having built-up area of less than 150000 sq mts comes under category of B2 and does not require EIA Report. Total built up area of Interim Government Complex building is 58,655.43 sq.mts and comes under category of B2 and does not require EIA Report.

5. Total site area is 45.129 acres and developed area is 27.082 acres.

Decision of SEIAA: The Authority opined that on examination of recommendations of the SEAC, no further action is required in the matter at this juncture.

The Committee passed resolution that all mining projects including major mineral mining projects upto 25 Ha will be treated as B 2 category projects.

Accordingly the committee recommended to consider request of proponent of proponent to exempt from public hearing.
