The Authority after detailed discussion and deliberation decided the following:

- 1. Serial No. 1: The proposal was deferred in 5.117th meeting of the Authority held on 2.4.2024 for submission of clarification on disparity in Khasra Nos. in documents submitted along with the proposal. Now, PP has clarified the correct Khasra Nos. of the proposal which are 842, 843, 836 and 1199/835. PP has also submitted supporting documents such as Lease Sanction order and Lease Agreement. Hence, the Authority accepted the recommendations of SEAC and decided to approve EIA/ EMP and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- Serial No. 2: The Proposal was deferred in 5.120th meeting of the Authority held on 30.4.2024 for submission of parking provisions of 675 ECUs as decided during the course



of discussion. In addition, PP was directed to submit an affidavit of the Consultant, clarifying whether the proposed project is one of violation or not and an affidavit of PP regarding no spill over of vehicles of the proposed commercial complex. Now, PP has submitted the revised Parking provision of 675 ECUs encompassing 552 Cars and 123 Scooters along with the other required documents. Hence, the Authority accepted the recommendations of SEAC and decided to **grant EC** to this proposal.

- Serial No. 3, 15, 19: The Authority accepted the recommendations of SEAC and decided to close and delist these proposals.
- 4. Serial No. 4: The Authority accepted the recommendation and additional conditions of SEAC and decided to grant Re-appraisal of EC issued by DEIAA to this proposal. The Mining Department may be directed to take an appropriate action for the excess production carried out in 2013-2014 and 2014-2015 in accordance with the order of Hon'ble Supreme Court dated 02.08.2017 in the matter of W.P. (C) No. 114/2014 Common Cause vs Union of India.
- Serial No. 5, 7, 24: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant ToR to these proposals.
- 6. Serial No. 6, 9: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to these proposals. PPs shall ensure to comply with the conditions imposed in the certificate issued by the Water Resources Department.
- 7. Serial No. 8: The Authority accepted the recommendation and additional conditions of SEAC and decided to grant Re-appraisal of EC issued by DEIAA to this proposal. PP shall ensure to comply with the conditions imposed in the certificate issued by the Water Resources Department.
- Serial No. 10, 12, 23, 34: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to these proposals.
- 9. Serial No. 11, 14, 16: The Authority accepted the recommendations and additional conditions of SEAC and decided to approve EIA/EMP and grant EC to these proposals. PPs shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 10. Serial No. 13: In this proposal, affidavits submitted by the PP and Consultant do not state anything on the compliance or non-compliance of Common Cause Judgement in their affidavits. Hence, the Authority decided to defer this proposal for submission of affidavits in the prescribed format, within 45 days.





- 11. Serial No. 17, 18: In these proposals, the recommendations of SEAC are accepted up to the extent that these applications may be closed and delisted. However, in the instant proposals, the ECs issued by DEIAA on 26.11.2018, were for expansion over and above the capacity granted by the competent authority SEIAA on 19.7.2015 and 17.7.2015 respectively. Since the ECs issued by DEIAA were without jurisdiction, such ECs with the expanded capacity stand null & void. PPs are directed to restrict the production to the capacity as approved in the ECs issued by SEIAA dated 19.7.2015 and 17.7.2015 respectively. RSPCB and the Mining Department may be directed to enforce the same. Also, once the stay order imposed by the Hon'ble Supreme Court dated 2.1.2024 on the violation related OMs 7.7.2021 and 28.1.2022 is lifted and or new directions given, PPs may apply for EC for expansion in production capacity under the category of violation as per the procedure so finalised.
- 12. Serial No. 20: The Authority decided to defer this proposal. PP is directed to submit details of the publicity done for Public Hearing to inform the local villagers along with proofs of the same. In addition, PP may also submit NOC from the WRD Department in respect of the barsati nallah at 25m from the lease area, within 45 days.
- 13. Serial No. 21, 22, 26, 27, 29, 30, 31, 35, 36, 37, 38, 39: The Authority accepted the recommendation and additional conditions of SEAC and decided to grant Reappraisal of EC issued by DEIAA to these proposals.
- 14. Serial No. 25: The Authority accepted the recommendations of EC and decided to grant Re-appraisal of EC to this proposal with the additional condition imposed by SEAC that the PP shall abide by the final outcome of Hon'ble Supreme Court in WP (C) no. 1394/2023 and/ or any further OM issued by the MoEF & CC and to comply accordingly.
- 15. Serial No. 28: In this proposal, PP and Consultant have not submitted their affidavits stating whether the instant proposal is one of violation or not. PP has also not submitted the affidavit regarding implementation of Cluster EMP. Hence, the Authority decided to defer this proposal for submission of affidavits of PP and Consultant, within 45 days.
- 16. Serial No. 32: The Authority accepted the recommendation of SEAC and decided to close & delist this proposal. RSPCB and the Mining Department is directed to ensure that there is no production to be carried out without valid EC.
- 17. Serial No. 33: The Authority accepted the recommendation and additional conditions of SEAC and decided to grant amendment in EC to this proposal.
- Serial No. 40, 43, 44, 45: The Authority decided to grant Transfer EC to these proposals.

19. Serial No. 41, 42, 46 to 77: The Authority decided to grant Transfer EC to these proposals with a direction that since these were the ECs issued by DEIAA, the PPs concerned shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28.04.2023, Hon'ble NGT order dated 07.12.2022 and SOP dated 15.01.2024 issued by MoEF&CC.
