The Authority after detailed discussion and deliberation decided the following:

Now, PP has submitted the ATR for the non-compliance of condition no. 10 (vii) of submitted CCR. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to this proposal.

3. **Serial No. 3:** Proposal was deferred in the 5.118th meeting of SEIAA for *submission of ATR of non-compliance of General Condition no. 15 of submitted CCR.*


Now, PP has submitted the ATR for the non-compliance of General Condition no. 15 of submitted CCR. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to this proposal.

4. **Serial No. 4:** Proposal was deferred in the 5.119th meeting of and *called PP for a presentation to explain the project in detail.*


PP was heard and presentation was seen. The Authority is of the view that it is an eco-friendly project. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to this proposal.

5. Serial No. 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18: The Authority accepted the recommendation of SEAC and decided to grant Re-appraisal of EC issued by DEIAA.
6. Serial No. 19, 21, 22, 26, 27, 28, 30, 31, 32, 33, 34, 36, 37, 38, 39: The Authority decided to grant Transfer EC to these proposals with a direction that since these were the ECs issued by DEIAA, the PPs concerned shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28.04.2023, Hon'ble NGT order dated 07.12.2022 and SOP dated 15.01.2024 issued by MoEF&CC.
7. Serial No. 20, 23, 24, 25, 29, 35: The Authority decided to grant Transfer EC to these proposals.
