Note:Submit a copy of each of above documents - <u>Hard and Soft Copies</u> (<u>CD</u>) to the <u>Member secretary</u>, <u>Violation</u> (Note: Not by Name) by speed post so as to reach well in time.

- (ii) Compliance Report from Regional Office, MoEF&CC (Applicable for projects already having EC).
- (iii) The KML/Shape files should be emailed to mentioned at para No. 7 below at least 5 days prior to the meeting.
- (iv) The above all documents are required to be forwarded to the Chairman/Members of the Expert Appraisal Committee along with soft copy.

- All the documents including the hard copy of the presentation material should be legible and printed on both sides on ordinary paper. In case the size proposals for the Expert Appraisal Committee do not receive the proposals for the meeting, the Committee will not consider the project.
