The Authority after detailed discussion and deliberation decided the following:

- 1. Serial No. 1, 2, 4, 5, 6, 7, 8, 10 & 11: These proposals were deferred by SEIAA in its previous meetings as the distance from forest area was neither mentioned in Form 1 nor in the DCF Certificate. Same has now been mentioned in these proposals by the project proponents. Hence the authority decided to grant EC to these proposals.
- 2. Serial No. 3 & 9: The LoI of these proposals had expired and therefore these proposals were deferred by SEIAA. The Project Proponents have now submitted extended LoI letter according to which the LoI of the proposal is valid now. Hence the Authority decided to grant EC to these proposals.
- 3. Serial No. 12: This proposal is regarding the construction of a business centre of 11 floors with built up area of 22,116.37 Sq. m. The parking provisions for this business centre is only 246 ECUs. However, the Authority was of the view that it will require parking far in excess of 1000 ECUs keeping in view the

number of persons working on each of the eleven floors with an average size of 1000 Sq. m. and the visitors also who would be coming to the complex. The parking proposed is grossly insufficient even for the original project. The Consultant requested to discuss the issue with the project proponent in case any alternative solutions are envisaged. Hence the Authority decided to defer this proposal for additional information.

- 4. Serial No. 13: The Authority decided to close & delist the proposal.
- Serial No. 14 to 24: The Authority decided to grant Transfer EC to these proposals.
