

It is also noted that Timmidikunta is located nearby the project site. However, the Risk Assessment & Disaster Management Plan has not mentioned about the Hazards associated with Seepage of ground water / Rain harvesting water into the Cellars and failure of Mechanical ventilation system due to power failure and Mechanical break downs. Hence, the proponent is directed to submit revised Risk Assessment & Disaster Management Plan duly considering the above.
