anyincluding details of the court matters/Orders of the Court pertaining to the project if any, in original, duly signed by the company authorized signatory for Environmental Clearance, well in advance before meeting to Ministryâ€<sup>™</sup>s project section or utmost at the time of presentation, without which the proposal will not be considered.
