

Minutes of the 93rd meeting of State level Environment Impact Assessment Authority, Jharkhand held on 26th, 27th & 28th October, 2021.

The 93rd meeting of the State Level Environment Impact Assessment Authority (SEIAA) was convened on 26th, 27th & 28th October, 2021 in the office of SEIAA, Ranchi. The meeting was chaired by Shri S.E.H. Kazmi, Chairman, SEIAA, Jharkhand. The attendance in the meeting was as follows:-

The decisions taken in the 93rd SEIAA meeting are as follows:-

1. Discussion on matter related to:

- i. Letter no. PVUN/Township/1, dated 07.09.2021 from General Manager, PVUN, Patratu Ramgarh.

SEIAA considered the recommendation of SEAC in this regard and it was observed the conditions stipulated with regard to deposit of 10% CSR cost was recommended by the then SEAC. Accordingly EC was granted vide letter dated 07.02.2019.

The project Authority vide letter no. - PVUN/Township/1, dated - 06th July, 2021 has requested SEIAA to provide methodology for deposition of the security money in terms of EC conditions no. : para -B - specific condition no. - 1, preconstruction phase : point no. - (ii). Accordingly SEIAA based on recommendation of SEAC has provided the methodology for deposition of the security money vide letter no. - 102, dated - 14.08.2021.

The project Authority again requested vide Letter no. PVUN/Township/1, dated 07.09.2021 has that the direction mentioned in said condition for security deposition may kindly be waived off.


Hence, SEIAA unanimously decided that the said conditions were imposed on the basis of the recommendation made by erstwhile SEAC. So, SEAC is requested to look in to the provisions and verify the correctness of said condition then forward the clear recommendation for final decision.

- ii. Rehabilitation & Resettlement Package for HEC Displaced persons of Jharkhand by Greater Ranchi Development Agency Limited at Site 1, HEC area, Vill - Aani, Dhurwa, Dist - Ranchi, Jharkhand.

The above project proposal belongs to violation category and applied under the window period given by MoEF & CC vide notification dated - 14.03.2017.

The erstwhile SEAC vide its 82nd meeting held on 04-07 November, 2019 has recommended for grant of EC subject to submission of Bank Guarantee to the tune of Rs. - 3.83 crore in favour of JSPCB. According SEIAA in its 84th meeting held on 08.11.2019 has decided that Environmental Clearance will be issued subject to submission of the following:-

- a. An affidavit stating that project proponent will submit the payment of Environmental compensation duly assessed by CPCB for the damages caused to the environment.



- b. Receipt of bank guarantee submitted to the JSPCB of Rs. 3.83 Crore as suggested by the SEAC to SEIAA as well as SEAC.
- c. Timeline for completion of remediation plan and natural and community Resource Augmentation Plan to SEIAA and SEAC.

Since the project is pending for 02 years and no cognizance has been taken by project Authority so far. Even the compliance for the same SEIAA has already been written a letter to project Authority vide letter no. – 718, dated – 08.11.2019.

Hence, SEIAA ^{has} is unanimously decided that a reminder letter is to be issued to PA with the copy to Secretary Building and Construction Department, Govt. of Jharkhand for the compliance of the decision taken in 84th meeting of SEIAA held on 08.11.2019 within 1 month from the date of issual of letter, failing which the project will be delisted without any further reference.

2. SEIAA considered the recommendations made by SEAC in its 91st meeting held on 06th, 07th, and 08th October, 2021 for grant of delist to the following projects:



The SEAC has scrutinized the above projects in the light of Hon'ble NGT order dated – 13.09.2018, dated – 11.12.2018 and MoEF & CC, OM dated – 12.12.2018. Thereafter, SEAC has made unanimous recommendation for grant of Environmental Clearance of above mentioned projects proposals. The SEIAA based on the recommendations of SEAC unanimously decided to grant Environmental Clearance to the above mentioned project proposals subject to Hon'ble NGT order dated – 13.09.2018, dated – 11.12.2018 and MoEF & CC, OM dated – 12.12.2018.

- a. Providing for EIA, EMP and therefore public consultation for all areas from 5 to 25 Ha falling under category B-2 at par with category B-1 by SEIAA/SEAC as well as for cluster situation wherever it is not provided.




- c. If a cluster or an individual lease size exceeds 5 ha the EIA/EMP be made applicable in the process of grant of prior Environmental Clearance.

 - e. Revise the procedure to also incorporate procedure with respect to annual rate of replenishment and time frame for replenishment after mining closure in an area.
 - f. The MoEF & CC to prepare guidelines for calculation of the cost of restitution of damage caused to mined- out areas along with the Net present value of Ecological services forgone because of illegal or unscientific mining.

The Authority examined the recommendation of SEAC for grant of Environmental Clearance. On the matter of Jungle –Jhari land the Circle Officer, Khunti, vide letter no. – 459, dated – 18.06.2019 has certified that the said project does not belongs to forest land and the nature of the land as per Khatiyani is “TAND TEEN/RAIYATI (KAYMI)”. Which reflects that the land involved in the said project does’nt belongs to Jungle – Jhari nature.

Hence, the SEIAA based on the recommendation of SEAC unanimously decided to grant Environmental Clearance to the above mentioned project proposals subject to Hon’ble NGT order dated – 13.09.2018, dated – 11.12.2018 and MoEF & CC, OM dated – 12.12.2018.

- a. Providing for EIA, EMP and therefore public consultation for all areas from 5 to 25 Ha falling under category B-2 at par with category B-1 by SEIAA/SEAC as well as for cluster situation wherever it is not provided.



SEAC has made unanimous recommendation for grant of ToR. For renewal of existing mines a distance of minimum 100 m from the forest land has been decided by SEIAA in its 59th MOM held on 09.08.2018.

SEAC has recommended for grant of ToR which is not as per the existing guidelines. The Authority is of the view that the committee should find out about the provisions from other states, analyse and give the basis of differing from the existing guidelines regarding the distance from forest boundary. SEAC should also analyse the provisions under related Acts and Guidelines and should also consult SEAC of different states and recommend a proposal with respect to minimum distance from forest for proposals related to renewal of mining lease. Only after receiving of such proposal and recommendation from SEAC, a decision will be taken in the instant proposal.
