The Appeal coming on for hearing, upon perusing the Appeal and the affidavit, memorandum of grounds filed in Writ Appeal and the order of the High Court, dated 22.07.2021 & 02.08.2021 made herein and upon hearing the arguments of Sri.V.Ravinder Rao, Senior Counsel for Sri W. B. Srinivas, Advocate for the Appellant, Sri.K.Naveen Kumar, GP for Mines & Geology appearing for Respondent Nos.1 & 4, is not present, Sri.N.Harinath, learned Assistant Solicitor General for Respondent Nos. 2 & 3, and of Sri Sivaraju Srinivas, Advocate for Respondent No.5, the Court made the following.

**ORDER:**

*(Through Video-Conferencing)*

Heard Mr. V. Ravinder Rao, learned senior counsel appearing for the appellant.

Also heard Mr. Sivaraju Srinivas, learned counsel for respondent No.5.

Mr. K. Naveen Kumar, learned Government Pleader for Mines and Geology for respondent Nos.1 and 4 is not present.



Mr. N. Harinath, learned Assistant Solicitor General of India appears for respondent Nos.2 and 3.

On 22.07.2021 when the matter was listed, Mr. K. Naveen Kumar, learned Government Pleader for Mines and Geology appearing for respondent Nos.1 and 4 prayed for some time. Perusal of the aforesaid order goes to show that a submission was made by Mr. V. Ravinder Rao that after dismissal of the writ petition, a road is sought to be constructed and therefore, the respondents may be restrained from constructing the road. The aforesaid submission was controverted by Mr. Sivaraju Srinivas contending that the road has already been constructed and the same was being used. The said statement was again controverted by Mr. V. Ravinder Rao. In the aforesaid background, while accommodating Mr. K. Naveen Kumar and directing the Registry to list this case on 02.08.2021, we directed that the parties shall maintain status quo with regard to the road in question till the next date fixed.

When the matter was listed on 02.08.2021, again a request was made by Mr. K. Naveen Kumar to list this case on 09.08.2021. The interim order passed earlier was directed to remain in force till the next date fixed, while accommodating his prayer. The case was not listed on 09.08.2021 and is listed today.

Learned senior counsel for the appellant submits that the road is sought to be constructed over the patta land of the appellant and it is not that respondent No.5 has no alternative road. It is submitted that the aforesaid land is meant for the developmental activities of the appellant and the proposed corridor runs parallel to the township at a distance of 250 meters which would cause noise and dust pollution. It is pointed out that there is an alternative way down South of their mining lease area passing through further downward and towards East to reach the public road joining at South-east end of their mining lease area and then move towards North all along the public road to reach their plant. It is also contended that there is a railway line near the mining area of respondent No.5 laid by South Central Railway Line for M/s. Jay Pee Balaji Cements which can be used with the permission of the railway authorities.

Mr. Sivaraju Srinivas, on a specific query of the Court, has submitted that since the time the mining lease was granted to respondent No.5 way back in the year 2009, respondent No.5 had not started any operation in view of the bottleneck in transporting limestone which is to be extracted from the mining area. He has further submitted that though the railway line is existing, there is no station to enable transshipment of the quarried materials. He also contends that the submission of the learned senior counsel for the appellant that there is an alternative road is not correct.



We have perused the order of the learned single Judge and we are of the opinion that the matter will require consideration.

It is noticed that at the time of admission of the writ petition on 12.04.2019, interim order was passed suspending the impugned orders dated 23.05.2018 and 23.01.2019 and the interim order was continued throughout the duration of the writ petition before its disposal.

Considering the matter in its entirety, we deem it appropriate to order suspension of the orders dated 23.05.2018 and 23.01.2019. We further provide that the road in question which is said to have been laid after dismissal of the writ petition shall not be utilised by any of the parties during the pendency of the writ appeal.

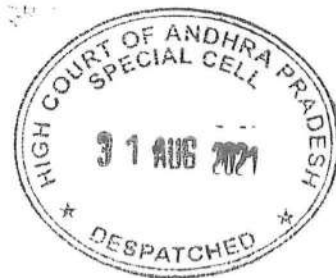
