

MoEF&CC, Govt. of India vide letter under reference has communicated that Environmental Clearance (EC) in respect of Daitari EC enhancement proposal has been considered by the Expert Appraisal Committee (Violation) in its 40th meeting held on 31.12.2020 and 44th meeting held on 18th – 19th February, 2021. The committee has recommended the proposal subject to compliance of certain conditions including the followings:

- An amount of Rs. 49.21 Crores towards remediation plan and natural and community.
- The project proponent shall be required to submit a bank guarantee of an amount of Rs. 49.21 crores towards Remediation Plan and Natural and Community Resource Augmentation plan with the SPCB prior to the grant of EC.
- The Bank Guarantee shall be released after successful implementation of the EMP, followed by recommendations of the EAC and approval of the regulatory authority.

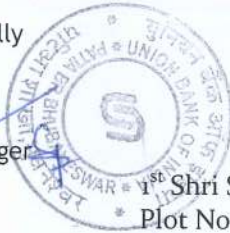


