The attention of the District Collector, Khammam is invited to the references cited and he is informed that Government in principle, agreed for allotment of Government & Assigned lands to an extent of Ac. 1031-19 gts situated in Ramanujavaram Village of Manuguru Mandal and Edulla Bayyaram, Seetharampuram villages of Pinapaka Mandal, Khammam District and to hand over advance possession of said land in favour of TSGENCO for establishment of 4X270 MW Thermal Power Plant.

2. The District Collector, Khammam is therefore, permitted to handover advance possession of the Government land which is free from encroachment and to initiate immediate action in removing the encroachments in the Government land which is under encroachments and handover advance possession of the same, in favour of TSGENCO, pending finalization of regular alienation proposals.

3. The District Collector, Khammam is requested to pay the appropriate ex-gratia after due negotiation, with regard to the assigned lands where there are no violation of assignment conditions.

4. The District Collector, Khammam is also requested to consider the R&R package to all including the persons those who are affected due to eviction from encroachments / possession of Government land, as per the existing policy.

5. The District Collector, Khammam is also requested to submit necessary proposals for regular alienation of land so handed over advance possession in favor of TSGENCO, at the earliest.
