**Subject: - Application on Form-I for Environmental Clearance for setting up Unit II for production of Clinker 2.0 MTPA, Cement 1.5 MTPA and 35 MW Captive Power Plant at Babupur Village, Raghuraj Nagar Tehsil, Satna District, Madhya Pradesh- regarding TORs**

Dear Sir,

We wish to submit that the Environmental Clearance was granted for existing Cement Plant with 1.09 MTPA Clinker, 0.6 MTPA Cement Grinding capacity and Captive Limestone Mine of 2.1 MTPA vide MoEF letter no: J-11011/29/2008-IA-II (I) dated 21<sup>st</sup> July 2009. The Environmental Clearance was subsequently amended for augmentation of clinker production from 1.09 MTPA to 1.3 MTPA vide MoEF letter No. J-11011/29/2008-IA-II (I) dated 10.09.2015.

We, now, propose to expand the capacity of cement plant by setting up additional Pyro Processing Line alongwith a Cement Grinding Mill and Captive Power Plant within the existing premises to manufacture 2.0 MTPA of Clinker, 1.5 MTPA of cement and 35 MW captive power plant located at Babupur Village, Raghuraj Nagar Tehsil, Satna district, Madhya Pradesh. The complex, upon completion of Expansion Plan, shall have Clinker capacity of 3.3 MTPA, Cement 2.1 MTPA and Captive Power Plant of 35 MW.

Accordingly, we are submitting online application (Form-I, Proposed TOR and Pre-feasibility Report) for subject project, as per MoEF&CC O.M. No.J-11013/49/2014-IA.I dated 6<sup>th</sup> June, 2014, for your kind consideration and prescribing Terms of Reference for the EIA/EMP study, please.
