**Sub :** Submission of Form-I & Pre-feasibility Report towards Environmental Clearance for the Expansion of Existing Sugar unit from 6500 TCD to 14000 TCD and Existing Co-Gen Power Plant from 18.14 MW to 62.14 MW at Krishnanagar, Hosur Post, Vijayapur district, Karnataka State by M/s Nandi Sahakari Sakkare Karkhane Niyamit.

We have a 6500 TCD sugar unit with 18.14 MW Cogeneration Unit at Sy.No 90, 92, Krishnanagar, Hosur Post, Vijayapur district, Karnataka State. We propose to increase the Sugar unit capacity from 6500 TCD to 14000 TCD and Cogeneration capacity from 18.14 MW to 62.14 MW at Krishnanagar, Hosur Post, Vijayapur district, Karnataka State.

In this regard we had applied Environmental Clearance (EC) Application for our proposed expansion project for Karnataka State Environment Impact Assessment Authority (SEIAA) for appraising for EC dated 09/11/2016. Our project was appraised in 174<sup>th</sup> State Environment Appraisal Committee (SEAC) dated 08/12/2016, the SEAC recommended to SEIAA for the issue of Standard ToR's with Additional ToR to conduct EIA Studies; the secretary of SEAC forwarded the proposal to SEIAA for further action.

The SEIAA perused the recommendations of SEAC in 128<sup>th</sup> SEIAA Meeting dated 23/01/2017, and have made the following observations;

- The proposed expansion of crushing capacity of the sugar plant is over and above the Environmental Clearance granted by the Ministry of Environment and Forests, Government of India vide letter No. J-11011/644/2007-IA II(I) dated 02.09.2008 and amended vide letter dated 18<sup>th</sup> November 2014. Therefore it is an integral part of activity covered under the Notification as A category. Environmental impact of sugar factory alone cannot be assessed in isolation of the existing distillery plant. Therefore this project needs to be appraised at EAC level as expansion of category A project for facilitating cumulative impact assessment.

- ii. From the records submitted it is noted that the industrial unit is having a co-generation component with generation capacity of 18.14 MW, which is proposed to be expanded to 62.14 MW. As per Sl.No. 1(d) of the Schedule to the EIA Notification, 2006 amended from time to time, the power plants of  $\geq 15$  MW with biomass as fuel require Environmental Clearance under the said notification. The applications and the enclosures do not reveal any information with regard to the Environmental Clearance obtained for Co-generation unit. However, as the power generation unit is also an integral part of the industry that has been considered by the Ministry of Environment and Forests, Government of India for Environmental Clearance.

The Authority after discussion opined that the proposed expansion requires Environmental Clearance from the Ministry of Environment and Forests, Government of India and therefore decided to advice the proponent accordingly. The Authority also decided to close this file and delist from the pendency.

Henceforth, we are herewith forwarding Form-I & Pre-feasibility Report for further processing of our application for our proposed expansion project to obtain Environmental Clearance to MoEF, New Delhi.

We request your good self to do needful to provide TOR to conduct EIA Studies and preparation of EIA Report.
