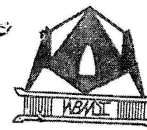

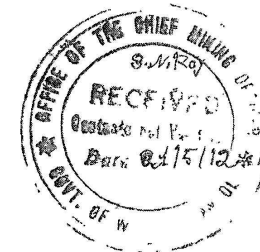
Sir,

In reference to your above mentioned memo and subsequent discussion held at your office on 09.05.2012 between you and the officials of JSW Natural Resources India Limited, we are submitting the modified Cadastral Plan, Topographical Plan and Block Location of Sitarampur Coal Block on Survey of India Topo-Sheet No. 73 i/13 & 73 i/14, all in 5 sets. The necessary changes that have been made are as per your memo referred above, in our already submitted Mining Lease application as below:

- 1) Area of the Coal Block has been reduced from 8.91 sq. km. to 8.3496 sq. km. due to change in Coal Block boundary.
- 2) Number of mouzas included in the Coal Block either partly or fully has been reduced from 11 to 9.
- 3) Two mouzas namely Khudka of P.S. Salanpur and Barira of P.S. Kulti have been omitted from the Coal Block area and plot list of mouzas Kulti, Badrichak, Punuri and Kultora of P.S. Kulti has been modified with respect to the changes in Coal Block boundary.

You are requested to do the needful so that we may get the necessary Grant Order at the earliest.

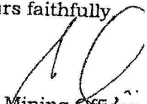
Subject- Application dt. 07.05.2012 for mining lease for coal in respect of the Sitarampur Coal Block of Raniganj Coal Field located in P.S. Kulti, Distt.-Burdwan.

Sir,

In connection with your aforesaid application this is to bring to your notice that the cadastral plan and topographical plan as well, which have been furnished along with the said application, differs slightly with the plan of Sitarampur Block, which was sent to the Chairman-cum-Managing Director, West Bengal Mineral Development & Trading Corporation Ltd. by the Director (T/CRD), CMPDIL vide, his letter no. CMPDI/DG/033.4/201-02, dt. 01.02.2008. Specially the western boundary of the block, as shown in the plans, submitted by you, need to be rectified by excluding the part of mouza Kulti falling on the north of G.T. Road. Further the part of mouza Khudka falling within P.S. Salanpur and part of mouza Barira falling within P.S. Kulti, which have been included within the Block, need be excluded from the applied area since these areas overlap with the lease areas of ECL and BCCL respectively. The southern boundary of the block needs to be finalized considering the northern boundary of the Kulti Block, which has already been finalized. Such rectification would obviously ask for rectification of the plot schedule too. The area of the block will also be reduced.

You are, therefore, requested to arrange for rectification of the plans and plot schedule as well. The plans (both cadastral and topographical) are to be prepared afresh and furnished to this office along with rectified plot schedule. Since the application cannot be processed at this end in absence of the said documents, an expeditious action is highly solicited.
