We are proposing to install 60 KLD capacity grain based Extra Neutral Alcohol (ENA) Production Plant at Vill: Basudevpur, PO: Ramkrishnapur, Block/ PS: Kulpi, District: 24 Parganas (South) in West Bengal, for which we are submitting the online application along with final EIA Report.

It would be relevant to mention here that Draft Terms of Reference (TOR) were discussed and finalized during the 24<sup>th</sup> Meeting of the Reconstituted Expert Appraisal Committee (Industry-2) held during 30<sup>th</sup> September, 2014 for preparation of EIA/EMP. Subsequently, the finalized Terms of Reference (TOR) were sent to us vide letter (Ref. F. No. J-11011/262/2014-IA.II (I)) dated 9<sup>th</sup> December, 2014, based on which the Draft EIA/EMP Report was prepared and submitted to West Bengal Pollution Control Board for the conduct of Public Hearing/Consultation. Subsequently, the Public Hearing was conducted on 25<sup>th</sup> June, 2015 at Kulpi BDO Office Meeting Hall, Dist. 24 Parganas (South) in West Bengal. All Public Hearing related documents are enclosed as Annexures – VI & VII in the Final EIA Report.

We hereby request you to take the necessary action so that an early Environmental Clearance could be issued for our proposed project.
